PHOENIX, Ariz. (January 5, 2004) - The Arizona Foundation for Legal Services & Education is pleased to announce that ten of Arizona's top high school civics and government classrooms will compete at the **17th annual "We The People...The Citizen and The Constitution" State Competition** on Friday, January 9th 2004. Opening ceremonies will begin at 8 a.m. in the La Sala Ballroom on the campus of Arizona State University West (located at 4701 W. Thunderbird Road in Glendale, Arizona). Arizona Supreme Court Chief Justice Charles Jones and Vice Chief Justice Ruth McGregor will be on hand to honor participating teachers and students at the 5 p.m. awards ceremony.

"We the People" is an intense semester-long curriculum that explores the philosophical underpinnings of U.S. Constitution, the history surrounding it, and the modern-day application of the Constitution to American life. "We the People" promotes civic awareness and responsibility in students and strengthens students' critical thinking and public speaking skills.

The program culminates in a simulated congressional hearing where students defend their knowledge of the Constitution in front of a panel of community judges. At this year's state competition, over 55 community leaders including Arizona attorneys, judges, Arizona State Legislators, state Supreme Court justices, and those in the academic field will serve on judging panels.

"The textbook is brilliantly written at a level easily understandable for high school students, this program should be mandatory for any citizen involved in our legal and political systems!" comments Judge Nicole Laurin, a City of Gilbert Municipal Judge and one of the judges at this year's "We the People" competition.

"We the People makes me realize that the future of America is in OUR hands and we need to take responsibility and learn about OUR government," states one of the competing students.

In 2002, Mesa's Dobson High School team won first place at the National We the People competition. This year, ten teams will compete for the chance to bring home another national title to Arizona:
