Mock Trial Tournament Tests Students' Knowledge of the Law

PHOENIX, Ariz. (March 12, 2003) - Eighteen high school teams from across the state will take part in a simulated courtroom trial to test their understanding of the legal system at the Arizona High School Mock Trial State Tournament on Saturday, March 22. The Arizona Foundation for Legal Services and Education and the Young Lawyers Division of the State Bar of Arizona are sponsoring the competition.

The 18 teams advanced to the state finals after participating in regional tournaments held throughout the state in early March.

At the state tournament, a predetermined set of facts is distributed to each team prior to the contest for participants to prepare both the prosecution and defense side of the case.

This year's hypothetical case focuses on what sentence should be given to a teenager convicted of aggravated assault with a dangerous weapon. As charged, under Arizona law, the 17-year-old faces a mandatory prison sentence of 5-15 years. Arizona law requires that the teenager be treated as an adult because of the seriousness of the crime committed, even though underage at the time.

Each mock trial team is composed of six to eight students who act out the roles of attorneys and witnesses. Judges determine the winning team based on the merits of the case and performance of the students.

Judges from Arizona's Superior Courts, the Arizona Supreme Court, the Federal Courts, and the city courts will judge the competition.

The all-day mock trial tournament begins at 8 a.m. on March 22, and takes place at the Sandra Day O'Connor Federal Courthouse, 401 W. Washington Street.

The winning state team will represent Arizona at the national competition May 8-10, 2003, in New Orleans.
